Best Practice: Ballot-Level RLAs

- With a good systems, processes and data, you can do ballot-level risk-limiting audits which limit the risk that tabulation errors or attacks result in getting the wrong outcome
 - In hundreds of contests, dozens of counties
 - Across overlapping districts in a state
 - Efficiently: audited less than ten thousand ballots statewide
- Simultaneously, opportunistically, gather evidence on and report risk levels for all the rest of the contests (2018 still work in progress)
- Colorado's new statewide system is among the most cost effective and best for auditing: central-count scanners with BMDs available for accessibility

Resources Available

- Four vendors presented and piloted systems that could do ballot-level comparison RLAs in 2015: central count scanning systems from Dominion, Hart, ClearBallot, ES&S
- Open source ColoradoRLA code available to support these audits, continues to be enhanced

Support for RLAs

- Widespread, transpartisan consensus on need for both paper ballots and audits.
 - o 2003 Four-party consensus in Boulder Colorado
 - 2017 EAC/NIST Voluntary Voting System Guidelines (VVSG) 2.0
 - 2018 Securing the Vote: Protecting American
 Democracy | The National Academies Press
- Huge steps forward, still much to do
- Why is it taking so long to adopt robust audits?
 - Elections are increasingly complicated
 - You can't easily audit the data you've got
 - You can't easily get the data you need
 - Critical Common Data Standards work by EAC / NIST

Common Data Formats

- We need format standards! EAC/NIST
 - John Wack: Overview of VVSG-Interoperability Common Data Formats (two presentations)
- Election Results CDF V1 published as SP 1500-100.
 - Used in OH, NC, LA County, other states in progress.
- V2 synchronizes with Google/VIP 5.1, adds JSON.
- Election Log Export CDF soon published as SP 1500-101.
- Voter Records Interchange CDF slated for review by VR vendors and then published as SP 1500-102.
 - Initial use in OH and by OSET.
- Cast Vote Records CDF schema to be published as SP 1500-103.
- Continued development and documentation of election process business models and voting method descriptions.

 - 4 Commitment

 - 8 Ending the random selection and examination of ballots cards
 - o 9 Hand Count
 - 10 Audit Conclusions Affect Outcomes

Convincing Officials of Election Outcomes

- ColoradoRLA includes rla_export tool to provide necessary data for Oversight Protocol in csv/json formats
- rla_report demonstration code in progress to precisely explain and implement oversight steps.
- Verifiers should of course implement or vet their own processes, code, etc.
- Level 1: Election Adminstrators
 - Colorado counties and state, based on their knowledge of the CVRs etc, dramatically limited the risk of an incorrect tabulation outcome in hundreds of contests

Far more than most states can say, very efficient!

Convincing Others of Election Outcomes

- Levels 2 and 3: Losers and the Public
 - Much more transparency than in the past
 - Still several crucial holes left in oversight protocol
 - Some summary data not available yet
 - Wrestling with ballot anonymity issues => no CVRs
 - Can't check totals, interpretations, etc.
 - Nevertheless, appreciate amazing ongoing accomplishments by state and counties under very challenging circumstances!
 - More to come!

Discrepancy Investigations

- Detailed reports still in-progress
- Software should inform Audit Board of each discrepancy right after entry. That would help investigation, quality control feedback, and trust in the process.
- Poorvi Vora and I have a document in progress on how to investigate discrepancies, preserving integrity, efficiency, flexibility
- More data would be invaluable in fine tuning the process

Remaining Challenges 1

- Enhance reporting convenience and analysis
 - Discrepancies, risk levels for opportunistically audited contests in arbitrary mix of counties
 - Automatic generation, publication of Audit Center for public
- Modularize software for use with external statistical modules, additional methods (SUITE, Bayesian, etc.)
- Handle In-Precinct/Vote center scanners, which randomize ballots and/or CVRs: complicate process of matching paper ballot with CVR
- Support batch-comparison audits (generally predictable risk reduction), ballot-polling audits (unpredictable, impractical for tight margins)

Remaining Challenges 2

- Foster collaboration between clerks, privacy experts, toolsmiths around preserving anonymity, especially for complicated situation in Colorado
- Audit more systems: VR, signature verification, envelope sorters

Targeted audits

- Encourage candidates, public to identify additional interesting ballots to target for auditing
 - o In addition to full random selection audit
- Could be chosen based on CVRs, mark density data, ballot images

Public engagement in verification

- Promote public participation in audit
- Print ballot tracking pages with QR codes
- App to photograph ballot + QR code
- Assist public tweets like "I verified this vote"
