# Milestones Achieved

- Perseverance, progress in auditing since 2003
- RLA law and rules, advised by experts
- 4 Vendors offer ballot-level comparison-RLA-capable systems for central count
- Open source software for coordination of state-wide auditing
- Publicly verifiable random draw
  
- All contests subject to audit, nearly all audited better than most places

# ColoradoRLA aka RLA Tool

- Manage coordinated risk-limiting audits
- Let state set parameters for the audit: risk limits etc
- Read CVRs from multiple jurisdictions
- Take Audit Board entries from each jurisdiction
- Determine discrepancies and when risk limits have been achieved
- Coordinate the audit thru multiple rounds if necessary
- Open Source software at <https://github.com/FreeAndFair/ColoradoRLA/>
- Developed by Free & Fair, under contract to Colorado Department of State
- generously supported by Galois
- Intense development schedule!

# Auditing metrics

- 56 counties did RLAs
- 50 ballot comparison, 6 ballot polling counties

Fresh new `r1a_export` data from Colorado: preliminary numbers from comparison counties, pending cross-county contest matching

- 1.2 M ballots
- 6.6 M votes
- Nearly 3000 ballots audited
- Over 10000 votes audited
- Dozens of successful targeted RLAs
- Dozens of successful opportunistic RLAs
- Hundreds more contests audited to some degree

# Discrepancy example

- Note: just one candidate in bottom contest: Director District 5
- Audit Board interpreted bottom mark as no vote for that candidate

# Discrepancies

(Excluding 2 counties with which hadn't had adequate opportunity to learn to use the tool. And note that due to the compressed development schedule, no one really had adequate opportunity!)

- 26 discrepancies between CVRs and Audit Board entries
  - 1 real discrepancy
  - 3 due to audit data entry errors
  - 22 not yet investigated
- Note Audit Board currently gets no feedback about discrepancies other than reports later on

# Discrepancy Investigations

- Tool should probably inform Audit Board of each discrepancy right after entry. That would help investigation, quality control feedback, and trust in the process.
- Poorvi Vora and I have a document in progress on how to investigate discrepancies, preserving integrity, efficiency, flexibility
- More data would be invaluable in fine tuning the process

# Remaining Challenges 1

- Automate anonymization of CVRs so they can be verified by public. See [Preserving Anonymity of Cast Vote Record](#)
- Provide real-time public dashboard, support Public RLA Oversight Protocol
- Support
  - Multi-county contests
  - Sampling from multiple overlapping districts
- Since RLAs are defined as auditing against voter-verifiable paper ballots, should treat electronic-only UOCAVA ballots as non-voter-verifiable, and thus as votes for the losers.
- For other states: handle In-Precinct/Vote center scanners, which randomize ballots and/or CVRs: complicate process of matching paper ballot with CVR
